#### Political Activities of The Official Monster Raving Loony Party for the Year 2008

The Party was more settled in 2008.

All Loony candidates in the three by-elections came seventh place. On 22nd May Flying Brick polled 236 votes in Crewe & Nantwich.

26<sup>th</sup> Jun Bananaman increased that polling 242 in Henley.

Mad Cow-Girl raised the bar with a poll of 412 in Haltemprice and Howden.

#### May 2008 Local Elections

Bob (Retard) Stanton, 67 votes at Rowhill Constituency in Aldershot, Hampshire.

Sheikmahand won 46 votes at Swale Borough Council, Kent.

Mad Mike Young won 110 at Minster Cliffs Ward of the Borough of Swale, Kent. Jon (Imwy Eddon) Smith won a massive 170, at Belper North Ward, Derbyshire.

#### **Membership**

The Official Monster Raving Loony Party Membership runs from 1<sup>st</sup> Jan to 31<sup>st</sup> Dec – the calendar year. In 2008 we had 173 paying members.

Members are encouraged to renew at the end of the year. Some choose to miss a year but renew the year after, so unless they resign, all are kept on the database.

All candidates who have stood in a previous General Election are automatic members and don't have to pay membership over the course of the following parliamentary term.

Up until 1996 The Official Monster Raving Loony Party had a one-off payment for Lifetime Membership. On 31<sup>st</sup> Dec 2008 there are 1181 OMRLP Lifetime Members, of varying description, who are alive but not paying. A couple have passed on to the most senior role of Spiritual member since last year. The Loony Party think these members have more influence than the rest of us.

#### **Review of Financial Activities**

Our earning is from membership subscriptions supplemented by merchandise sold through the website shop. Flying Brick was planning to lend one trillion pounds to The Bank of England but was stopped by RU Seerius and Howling Laud, they gently suggested the Loonys' would better remain aloof to the credit crisis.

#### Receipts and payments

In 2008 we have had 173 subscribed members at £9.99 = £1,728.27

We have sold 34 T-shirts at £12.49 = £424.66

We have sold £101.63 other merchandise including badges and key-rings.

Total T-shirts and other merchandise = £526.29

In July we had a donation of £5- from Mr P Wordsworth of St James, Barbados.

We have bought only a small amount of stock this year, someone will have to soon or we will run out.

#### **Assets**

The parties assets are stock in hand of £240-, and as of 31<sup>st</sup> Dec 2008 a bank and Paypal balance of £2,040.90. The Party has no equipment; we are saving up to buy a private jet.
