<u>Political Activities of The Official Monster Raving Loony Party for the Year 2013</u> 2013 By-elections

We stood in two by-elections in 2013; Howling Laud Hope came ninth out of fourteen candidates at Eastleigh with 136 votes and polled 197 votes on the 2nd May in South Shields.

Party Conference

Membership

Membership is still £9.99 a year; in 2013 the Loony Party had 132 paying members. We have lots of virtual members in our Facebook and Twitter groups.

Review of Financial Activities

We have a large deficit in our bank balances this year of £1,599.93. This is due to a large increase in spending on our 'stock in hand' but it is also due to a smaller membership and heavier spending on expenses. I've told everyone to tighten their belts. I am hoping the Party can move away from selling T-shirts and badges and pay for our campaigns through crowdfunding and issuing a looncoin crypto currency.

Income & Expenditure

Our receipts from membership totalled £1,318.69 and merchandise £805.64 We paid £1,186.60 to Designer Prints for T-shirts, £424.98 to Doreen Greaves for rosettes and £97.80 for badge blanks.

There are 293 T-shirts, 6 mugs, 210 rosettes which totals a stock-in-hand, of £1,814

<u>Assets</u>
The Party's assets as of 31st Dec 2013 are a Bank and Paypal balance of £4,448.73 and stock-in-hand, comprising of mainly T-shirts, of £1,814. The Party has no equipment.
