### **Political Activities**

We contended five parliamentary by-elections.  
Howling Laud Hope stood in West Lancashire on the 9<sup>th</sup> Feb and polled 210 votes.  
On the 20<sup>th</sup> July Howling Laud polled 32 votes in Uxbridge and South Ruislip while Sir Archibald Stanton achieved 172 votes beating 'Heritage' and 'Climate' candidates.  
On the 19<sup>th</sup> October Howling Laud collected 155 votes at Tamworth By-election while local candidate The Mid-Bed Minx polled 249 in the Mid Bedfordshire by-election placed in sixth position out of twelve candidates..

### **Party Conference**

The 39<sup>th</sup> party conference was held between Thurs 28 Sept – Sun 1<sup>st</sup> Oct at The Neuadd Arms Hotel, Llanwrtyd Wells.  
We were entertained by The Faux Fibbers and the wonderful Becca O'Hara Band on Friday night. On Saturday afternoon we experienced the excellent Black Pig Border Morris troupe and later a tribute to the late Barmy Lord Brockman, with a magnificent rendition of Eye of The Tiger on the kazoo.  
Saturday evening The Faux Fibbers, followed by Gripper and the Gurnards, with a guest appearance from a zombie formerly known as Chinnners. Lux Delieux, performed burlesque, which was magnificent, and the evening then continued to get crazier with musical entertainment from Sir Dangerous Dave and friends.

Membership is still £12- a year. This year our membership `stayed fairly constant at 311, including a group membership for The Black Pig Morris troupe.

**Review of Financial Activities**

The Party has had a decrease in assets this year with a decrease in our bank accounts of £319.33 and a decrease of stock and equipment of just under £392.25
