Political Activities

We contended four by-elections. Nick the Incredible Flying Brick stood at Hartlepool on the 6th May. His 104 votes cast set a new record for a 14th placed candidate in a UK parliamentary election. Howling Laud, our party leader, achieved seventh place out of fourteen candidates with 107 votes, at Batley & Spen on the 1st July. Mad Mike, who is one of our longest standing members, gained 94 loony votes at Old Bexley & Sidcup on the 2nd Dec. Howling Laud enjoyed his second by-election of the year winning eighth place out of a pack of 14 candidates with 118 votes in North Shropshire on the 16th Dec.

We made political history by putting forward thirteen candidates in the Kingston Council by-election for Chessington South in May. All the candidates were regulars in the Lucky Rover Pub and are known as the 'Lucky 13!' A heart-warming total of 92 votes were secured.

In other May elections, we had an 'Asylum of Loonys' contesting various Town and Parish elections around the country, we won six seats.

In October Barmy Lord Brockman achieved 43 votes standing in the Twyford Ward By-election for Evesham Town Council.

Party Conference
