Political Activities

We registered our name in Welsh 'Plaid Swyddogol yr Anghenfilaidd Ddihirod Gwallgof'

We contended three parliamentary by-elections.

The Good Knight Sir NosDa came ninth out of eleven candidates in Birmingham Erdington on the 3rd Mar with 49 votes.

Sir Archibald Stanton achieved eleventh out of fifteen candidates with 171 votes at Wakefield on the 23rd Jun.

Howling Laud Hope our party leader came seventh out of eight in City of Chester on the 1st Dec polling 156 votes.

In the May elections, we had an 'Asylum of Loonys' contesting eleven seats including six in Chessington and an assortment of various Town and Parish elections around the country. We won six seats and our party Leader Howling Laud was returned unopposed to the Fleet Town Council. In August our membership and merchandise secretary Baron Von Thunderclap threw his large pith helmet into the ring and stood in the Bolney ward by-election.

Party Conference

The 38th party conference was held between Thurs 22nd – Sun 25th September at The Victoria Inn, Coalville, LE67 3FA. Alex Zoboli of 'Cesura' productions came from Italy, he was writing a documentary and book on World Politics.

We set the record for the first crowd to play 'God save the King' and were entertained by Lord Tiswas Bunnyboy serenading the assembled with 'Bright Eyes' accompanied by 41 kazoo's. We enjoyed 'Gripper and the Gurnads', 'Morderstein' & 'Audiorage', on Friday night then 'Murder of the Crows' and 'Cocked and Loaded' on Saturday, all held together by the resident compère 'Mr Bad Axe.

Membership

Membership is still £12- a year. This year we maintained our membership at 321, including a group membership for The Black Pig Morris dancers.

Review of Financial Activities

The Party has had a decrease in assets this year with a decrease in our bank accounts of just under £1500 and an increase of stock and equipment of just under £800-

Our receipts from membership totalled £3,305.33 and merchandise £178.97. We were gifted a legacy of £210.
